PERMISSION TO AERIAL SPRAY TO
MITIGATE MORMON CRICKETS ON PRIVATE PROPERTY

DESCRIPTION OF WORK TO BE DONE:

The Rio Blanco County Weed & Pest Management Department partners with private landowners to mitigate noxious weed and pest infestations. Rio Blanco County, in partnership with White River and Douglas Creek Conservation Districts are conducting Mormon Cricket monitoring and control activities from March through October within defined Rio Blanco County. Mormon Cricket monitoring and control activities may include:

- Identifying and mapping locations where Mormon Crickets exist
- Applying pesticides and biological controls to the areas found to have Mormon Crickets
- Monitoring treated locations for treatment efficacy and population response

This permission will be effective during 2024. This permission may be terminated by either party at any time by giving written notice of the effective date of expiration. It shall also be automatically terminated upon the sale of this property.

Rio Blanco County will only conduct Mormon Cricket mitigation strategies on the above- described property with a signed permission to access. Signing this document does not guarantee that activities will be maintained at all times during the active season, nor does it guarantee that these activities will occur throughout the property described above.

Rio Blanco County will employ licensed pesticide aerial applicators trained in accordance to the applicable laws and regulations set forth by the Colorado Department of Agriculture. All pesticide applications shall be made in accordance with the pesticide labels. By signing this permission, private landowners and their authorized representatives acknowledge that they are responsible for notifying Rio Blanco County Weed and Pest Management of livestock grazing periods and any requests for grazing deferrals not provided on the pesticide labels. To avoid

off-target drift and damage, Rio Blanco County will refrain from pesticide use in the event of wind and high heat. By signing this permission, private landowners and their authorized

representatives acknowledge that the property described above may not be treated in it's entirety, or at all, also, an acceptable level of off-target damage is to be expected, and hereby agree that Rio Blanco County shall not be held responsible for any potential accidental or consequential damage caused to off-target species.
