**PERMISSION TO AERIAL SPRAY TO  
MITIGATE MORMON CRICKETS ON PRIVATE PROPERTY**

**DESCRIPTION OF WORK TO BE DONE:**

The **White River and Douglas Creek Conservation Districts**, in partnership with private landowners, are conducting Mormon Cricket monitoring and control activities from March through October within the defined boundaries of Rio Blanco County. These activities are designed to mitigate pest infestations and protect local resources. Mormon Cricket monitoring and control activities may include:

- Identifying and mapping locations where Mormon Crickets exist
- Applying pesticides and biological controls to areas found to have Mormon Crickets
- Monitoring treated locations for treatment efficacy and population response

This permission will be effective during **2026**. Either party may terminate this permission at any time by providing written notice of the effective date of expiration. It shall also be automatically terminated upon the sale of the property described above.

The **Conservation Districts** will only conduct Mormon Cricket mitigation strategies on the property described above with a signed permission to access. Signing this document does not guarantee that activities will be conducted at all times during the active season, nor does it guarantee that these activities will occur across the entire property described above.

Licensed pesticide aerial applicators, trained in accordance with the applicable laws and regulations set forth by the Colorado Department of Agriculture, will perform all pesticide applications. All pesticide applications shall adhere to the pesticide labels. By signing this permission, private landowners and their authorized representatives acknowledge that they are responsible for notifying the Conservation Districts of livestock grazing periods and any requests for grazing deferrals not provided on the pesticide labels. To avoid off-target drift and damage, the Conservation Districts will refrain from pesticide use in cases of wind or high heat.
